ALLOTMENT COMPLETED FOR RENOUNCEABLE ENTITLEMENT OFFER

22 November 2019

Wagners Holding Company Ltd (**Wagners**) is pleased to confirm that it has completed the allotment of shares pursuant to the Company's renounceable entitlement offer (the **Entitlement Offer**) as announced on 29 October 2019 and which closed on 15 November 2019.

In accordance with the Entitlement Offer eligible shareholders were entitled to apply for new shares on the basis of 1 new share for every 6.25 existing shares held at the record date. The Entitlement Offer was conducted at an issue price of \$1.55 per share. The Entitlement Offer was fully underwritten by Morgans Corporate Limited.

Wagners confirms that 25,821,297 fully paid ordinary shares have today been issued raising \$40,023,010.35 before costs. The Company now has 187,196,887 fully paid ordinary shares on issue.
